Holstein Heifer Calves: Number 1 82-104 lbs few 45.00-55.00; Number 2 86-92 lbs few 27.50-35.00; Green 64-84 lbs few 10.00-17.50; Red 90-98 lbs few 15.00-22.50.

Dairy/Beef Crossbred Calves: Bulls 104 lbs individual 172.50; Heifers 76 lbs individual 100.00.
