

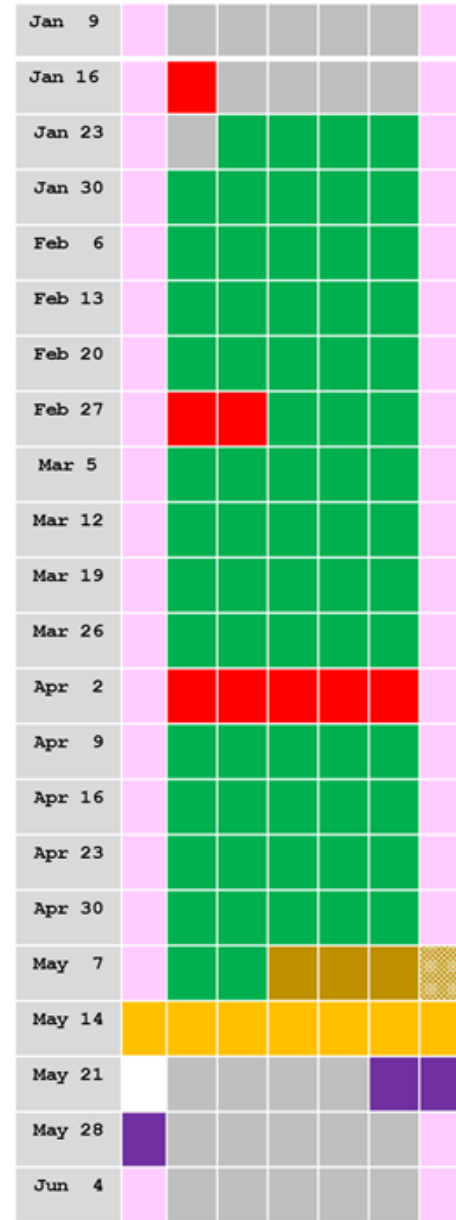
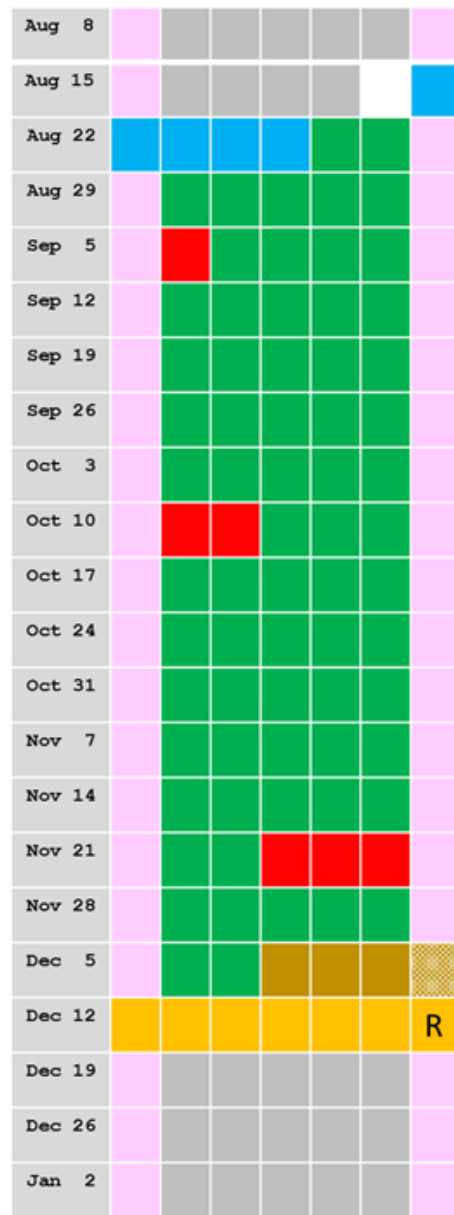

# 1. Orientation

# Orientation

Current: (Fri)-Sat-Sun-Mon

New: (Fri)-Sat-Sun-Mon-Tue-Wed

Two Facts:

1. The “new” orientation period looks like Cornell’s pre-2013 orientation period.
2. A 5-day orientation period is a little bit shorter than the typical orientation period offered by our peers.

# To Start the Ball Rolling

Obviously, this has to be informed by what goes on in departments and graduate fields.



# Things to Keep in Mind

1. Saturday and Sunday: Parents around. Fewer faculty and staff around. Better for University-Wide programming.
2. Topics that probably deserve expanded treatment: academic integrity, free speech issues, basic study skills.
3. We are mandated to provide heightened coverage of Title IX and anti-bias issues
4. Late-night University programming needs to be informed by “early morning” college programming.
5. Should the freshman book project be resurrected in some a new form?

## **Process:**

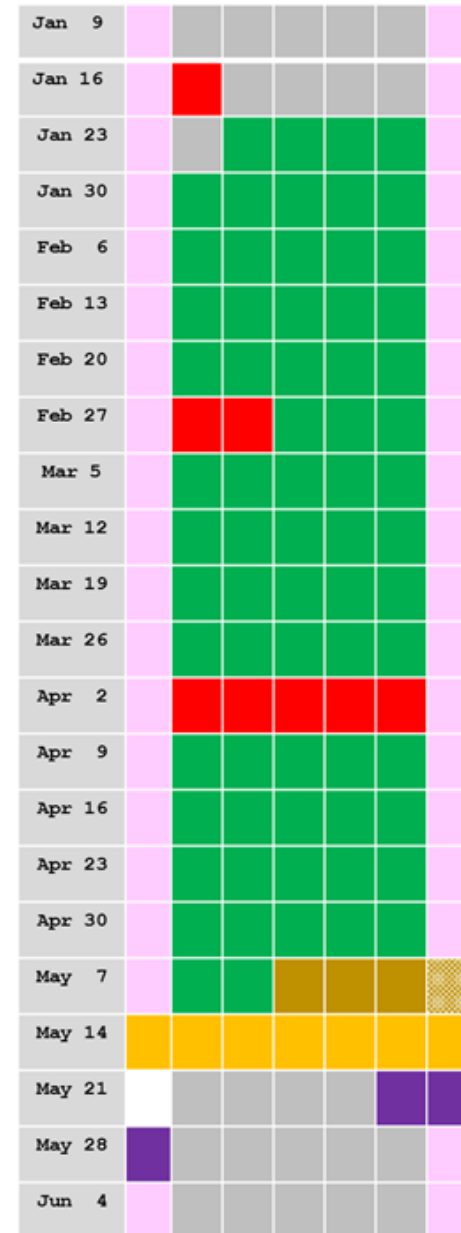
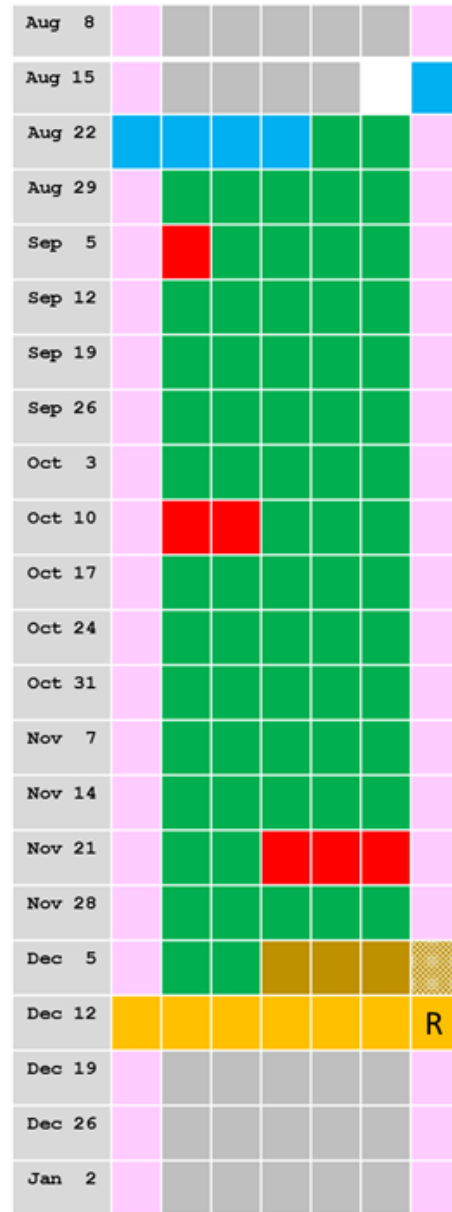
**New Student Programs coordinates everything as usual.**

**New programming that deals with climate and ethics must be developed very carefully with full involvement of the Faculty.**

**The entire community (students+staff+faculty) must be given the chance to publically comment on the new orientation plan before it becomes “official”. This doesn’t have to be complicated or labor-intensive. A single-question survey floated in November should suffice: “Here is a rough draft of the new orientation schedule—what do you think?” Responses could be posted on a designated webpage as was done during the calendar project last year.**

## **Proposed Process:**

**With student and faculty input all along the way, the EPC reviews the rules associated with prelims, study days, and finals and proposes improvements.**

**The Senate considers and votes on the EPC recommendations.**

# 3. Final Exam Scheduling

# Final Exam Scheduling & Execution

## Optimization Issues

1. Number of back-to-backs, 3-in-24s, direct conflicts
2. Big course exam slots: Freshman Friendly vs. Grader Friendly

The Student Assembly has passed a [resolution](#) that asks for a review of the prelim and final exam scheduling procedures and the rules associated with “too many exams in a short period of time.”

## **Proposed Process:**

**Alternative optimization systems are applied to Fall 2017 and Spring 2018 data.**

**Their performance is evaluated and compared using metrics that are identified by students and faculty**

**The EPC assesses the results and advises the Registrar.**



# Length-of-Final Exams

Should our final exams be 2 hours long? Not radical, e.g., U Penn and Michigan have 2-hour exams

The role of final exams is evolving—time for a rethink?

The number of extra-time exams that are given each semester has approximately doubled in the last five years.

## **Proposed Process:**

**The EPC should look into this with obvious input from the Learning Strategies Center, the Registrar, and Student Disability Services.**

# 4. Evening Prelim Scheduling

# Evening Prelim Scheduling

Researchers in ORIE have studied ways to optimize the scheduling of evening prelims and there has been a preliminary dialog with the Registrar's office.

[Somewhat related topics include the 4:30-7:30 [off-limits policy](#) and [the policy that states the evening exams must be on Tuesdays and Thursdays only.](#)]

## **Proposed Process:**

**The dialog should reach some kind of conclusion in advance of the annual February meeting that will decide the 2018-19 evening prelim schedule.**

# 5. Religious Holiday Observance

# Problems

Uneven respect for the [Formal policy](#) and what the [Faculty Handbook](#) says.

Students feel awkward in approaching faculty about accommodations.

## **Proposed Process:**

**Work on this issue should proceed under the auspices of Cornell United Religious Work and the Dean of Faculty Office. New procedures and guidelines will require review by the SA, the GPSA, the Senate, and the Associate Deans Group.**

# 6. Slope Day Placement

# Slope Day: Last Day of Class or the Day After?

## Current Calendar

Spring-semester classes end on a Wednesday.

Slope day is held on Thursday.

## New Calendar

Spring-semester classes end on a Tuesday.

Slope Day is held on Tuesday or Wednesday

# Tuesday or Wednesday?

Input from [Cornell Health](#) and the [Slope Day Programming Board](#) is required.

Faculty and student thinking needs to be assessed by the Senate and the Student Assembly.

There is an [Alternative Slope Day](#) initiative.

## **Proposed Process:**

**Work on this issue should proceed under the auspices of the Office of Student and Campus Life and the Dean of Faculty Office once the 2018 Slope Day Programming Board is formed.**



# 7. Senior Days

# Senior Days

The number of days between the last exam date and Commencement is increasing by 3.

Extra programming is required:

Engaged Cornell has “community project” ideas.

The 2017 Senior Days Committee had ideas.

## **Proposed Process:**

**Work on this issue should proceed under the auspices of the Office of Student and Campus Life once the 2018 Senior Days group is formed.**
