## **On Transparency**

**Be it resolved** that the administration makes available the unredacted final reports of the Reopening Committees as soon as they are communicated to the President to ensure that faculty, whose futures are critically affected by the reports' recommendations, are adequately informed of the deliberations that inform the administration's decision-making process.

**Be it further resolved** that the administration work more closely with the Financial Policies Committee of the Faculty Senate during the pandemic and its aftermath to ensure that the faculty is adequately informed, prior to decisions being made, about the economic realities facing the university and about the tradeoffs associated with forthcoming decisions.

#### Basic principles:

- Shared governance requires participation, and *informed* participation requires transparency and maximum information.
- Both transparency and availability of ample information are key to establishing a sense of common purpose and trust among participants in shared governance.

#### Moreover:

- The university is asking the faculty to continue its unprecedented effort to reallocate time, revise instructional modes, and intensify our teaching efforts in AY2020-21 in the face of the coronavirus pandemic, and
- The university is asking the faculty to make considerable personal financial sacrifices to address expected budgetary deficits
- Quality and adequacy of information from the administration have profound effects on faculty morale

# On Using the Endowment

**Be it resolved** that the University should draw upon its endowment (or borrow against the endowment)\* in all variants of its plan to address the projected deficit, in order to better equalize the economic burden on all parties, past, present, and future.

- Faculty feel they are being asked to make extraordinary contributions (e.g., to work unpaid over the summer preparing to teach online in the fall) and at the same time to shoulder a major burden of the measures proposed to address projected deficits.
- They are required to give up either a portion of their salary in the state-supported colleges or a year of contributions to their retirement accounts in the endowed colleges under all versions of the plan to meet the projected deficits for the next academic year.
  - It is unclear how the equities of these two approaches are being calculated.

- Faculty support a progressive approach to allocating the deficits.
- But there is a negative impact on both faculty morale and the public perception of Cornell from the fact that the university plans to reserve any draw upon its endowment until and unless the worst case scenario occurs.
- A plan to meet the deficit by drawing upon all possible sources, including from the endowment under all scenarios (or, alternatively, borrowing against the endowment), appears to many to be a more equitable approach.
