- 3) A photocopy of each animal's health papers do not have to accompany the entry form. **It is imperative that you bring the original health papers with you for inspection upon arrival on the Fairgrounds.**
- 5) Check with your 4-H agent or authorized representative to be sure that you are covered with accident and health insurance!
