The University does not currently offer a master's or doctoral degree in women's and gender studies. However, the Women's, Gender, and Sexuality Studies Department offers a 24-credit graduate certificate. Graduating with the Certificate:

No later than Friday of Week 2 in the term of graduation (for the graduate certificate, the graduate degree, or both the degree and the certificate), the student must apply for graduation online.

No later than Friday of Week 8 in the term of graduation for the certificate, the department/program must submit an online "Statement of Completion for Graduate Certificate" as well as a hard copy of the departmental program plan indicating the courses (titles, term taken, number of credits, and grade for each) being used to fulfill the requirements of the certificate. (Note: Effective Winter 2012, the departmental program plan will no longer be required.)
