PEF 208: title changed to “Fitness Barre”

III. Courses reviewed:

J331 Digital Video Production: pre-reqs need to be clarified, “mid-C” should state “higher than C-“ Readings listed in SEI, but not in syllabus

J342 The Creative Strategist: option for proposer to change title, not necessary but title is currently unclear. Syllabus needs to be edited for “accessible education.”

J352 Strategic Writing and Media Relations: SEI and syllabus not consistent, SEI is off on lecture hours

MUS 437 Documentary Field Recording: due diligence to ANTH and Folklore, syllabus vague

MUE 439 Orff-Schulwerk Pedagogy: should be a 4-credit course

MUS 483 Theory and Design of Audio Effects: title too long, confusion on “concurrent curricular changes,” syllabus needs better clarification on differentials, and “plug-in projects.”

MUS 479 Data Sonification: Proprietary software “Kyma” can be in syllabus but not in CIM. References need to be deleted

UGST 101 Introduction to University Study. Credits don’t match SEI, is this a hybrid course? See hybrid course rules on UOCC blog

HPHY 432 Neural Development: due diligence was complete but need reply from Kristin Hulslander

PS 319 The Politics of the Body: Due diligence needed from ANTH

CINE 370 Narrative Production II: Pre-req clarification needed, too many hours in SEI for credits
