

Washington County will still use the ballots previously used but several improvements have been made on that system.

**LETTER FROM AN ILLINOIS LEAGUE ABOUT ABOLISHING THE DEATH PENALTY**

Dear Fellow League Members:

The League of Women Voters of Illinois and the League of Women Voters of Evanston are bringing Abolition of the Death Penalty to the LWVUS national convention in June and we urge your support.

We are asking delegates to the LWVUS Convention to adopt this position by concurrence at the convention: "The League of Women Voters of the United States supports the abolition of the death penalty."

Soon your League will be receiving background materials and research on the death penalty in the mail so that you can come to the convention informed on this vital issue. For your convenience, we have also attached the materials to this email.

A Sunday morning and a Sunday evening caucus will be held at the convention hosted by the Maryland, New York, and Ohio Leagues. These Leagues adopted the death penalty abolition positions in 2005.

"Cosponsoring" means that the State League will contact all its local League delegates urging them: (a) to inform themselves with the materials they received from Illinois, (b) to attend the caucuses, and (c) to support and to be cheerleaders for the concurrence.
