## From Joyce's Desk

In January I began looking at early suffrage history so that I could write something each month to honor our LWV 90<sup>th</sup> Anniversary. Learning that our first state president, Florence Cotnam, was a featured speaker at the very first LWV Convention in Chicago on February 14, 1920 motivated me to search through her papers, which remain in the University of Arkansas's Special Collections. Also speaking at that important organizational landmark ninety years ago was the dynamic leader Carrie Chapman Catt. She described the purpose of the new organization in the following way:

"The League of Women Voters is not to dissolve any present organization but to unite all existing organizations of women who believe in its principles. It is not to lure women from partisanship but to combine them in an effort for legislation which will protect coming movements, which we cannot even foretell, from suffering the untoward conditions which have hindered for so long the coming of equal suffrage. Are the women of the United States big enough to see their opportunity?"

Are we big enough to take on the challenges of child poverty, climate change, equal access to health care, money's influence in elections, immigration reform, and arms control? It will take all of us. Your participation is needed to develop programs, take part in consensus activities, speak out as an advocate, and bring new people into League membership. As you think about renewing your membership or consider individuals to invite, remember those who are already working on or concerned about these important issues. Ask them to join forces with us and include the respected voice of the League with theirs as a way to make a difference.

### Big Child Poverty Rate Increase is a Wake-Up Call

The League's Oct. 20 meeting included a public forum titled "Rising Child Poverty in Northwest Arkansas," which highlighted the rapidly increasing poverty level for children in our region. The newest Census figures from the American Community Survey show that the child poverty rate in the 3<sup>rd</sup> Congressional District grew from 20 percent to 25 percent in just one year, from 2008 to 2009. Rich Huddleston, executive director of Arkansas Advocates for Children and Families, traveled from Little Rock to discuss his work as co-chair of the Legislative Task Force on Reducing Poverty and Promoting Economic Opportunity.

Ananda Rosa, social work coordinator at Fayetteville Public Schools, and Melissa Fink, principal at Jones Elementary in Springdale, discussed the challenges that poor children face every day in our county. While Rosa and Fink made clear that families in poverty are most often good and loving parents, they face challenges from lack of medical care and insufficient transportation to their own lack of education. Laura Kellams, LWVWC board member and Northwest Arkansas director of Arkansas Advocates, served as moderator. She reported that despite our region's reputation as relatively wealthy, our congressional district now has more children living in poverty than any other in the state.

About 45 people attended, and a reporter from Northwest Arkansas newspapers, Rose Ann Pearce, covered the event with a front-page story.

The committee, which worked on this program, will be meeting to develop consensus questions so that the LWVWC membership can include a section on the needs of children in poverty in our Program for Action. Consensus questions and information about the consensus activity will be sent to the membership.

Arkansas Advocates for children and Families will outline several of its legislative agenda items, as well as the Task Force recommendations, at a conference on Nov. 18 at the Jones Center for Families. ### **How YOU Can Help the Fayetteville Schools Address Childhood Poverty**

I feel blessed everyday to be living in Northwest Arkansas and to work for the Fayetteville Schools. There are many resources available to help our children and an even larger number of people who genuinely care about children. With that being said, there is still a large amount of need in our District and many meaningful volunteer opportunities.

Part of Fayetteville Schools Social Work Services is the “Outback”. It is a food pantry and clothing closet, which is free to all Fayetteville students and their families. There are many opportunities related to the Outback. Volunteers can be utilized for donations of clothing, coats, hygiene supplies, cleaning products, and, of course, food. In addition, volunteers can be helpful in managing and organizing donations. During the holidays we will also be depending on volunteers to help secure donations and fill Holiday baskets for over 400 families.

Individual schools have many opportunities as well. Each one has unique needs and can offer guidance regarding the best way to help. Washington Elementary invites volunteers to read to the children while ALLPS (our Alternative High School) welcomes volunteers to provide one on one tutoring for students in Math, Social Studies, and other subjects. Sometimes willing participants are needed to help with transportation for special evening events, such as Holiday programs or band or choir concerts, when bus service is not available. There are also students who wish to participate in extra-curricular activities or sports and do not have transportation to and from practices. This scenario and many others provide great opportunities to make a real difference in children’s lives.

## **Transportation Availability for All is Deficient in NW Arkansas**

Karen Rollet-Crocker, Transportation Representative and Action Chair, has attended many Ozark Regional Transit and composed a September 21, 2010, letter of support from the League of Women Voters. Joyce Hale signed this "Letter of Support for Achieving an Adequate Funding Level for the Ozark Regional Transit System". As the only regional transit system, ridership has increased substantially (paratransit ridership has risen 62% in the last year). ORT faces possible reduction in federal and local funding in the next two years and needs the support of all Northwest Arkansas communities and residents.

Karen and Sara Cain-Bartlett have outlined the topics and current transit concerns to be addressed in the **LWV April, 2011** program. The elderly, disabled, and low income residents of our area must be guaranteed access to accessible and reliable transportation to meet their needs. Topics to be addressed will include the special needs of the frail and disabled who depend on community transportation resources, the requirements of public transit systems to provide services to the disabled, community resources addressing these special needs, future changes in funding for NW Arkansas public transportation services when the area population exceeds 200,000, current needs identified for additional services, the needs of low income area residents to have dependable and flexible access to public transportation, and the role of NW Arkansas residents to advocate and support these special populations.

Marge Zinke will also be participating as a member of this program committee. Please refer any interested members to Karen to help in research, attend community meetings and in planning the program.

### **Stream-side Advocacy Needed from LWVWC Members**

The City of Fayetteville is proposing a controversial ordinance to protect water quality by restricting activity within 50 feet of streams and creeks. Water quality has been a long-standing priority with the local and state Leagues.
