# FNHA ADVOCACY FOR MT. KESSLER GREENWAYS

The Fayetteville Natural Heritage Association (FNHA: <a href="http://fayettevillenatural.org/index.php">http://fayettevillenatural.org/index.php</a>) is an advocate for preserving the Mt. Kessler Greenways in southwest Fayetteville. The east side of Fayetteville has significant greenspace (Lake

Fayetteville, Mt. Sequoyah Woods, Lake Sequoyah and Lake Wilson). Population growth to the west, has made protecting greenspace on the west side of Fayetteville a priority.

The Fayetteville City Limits encompass one thousand of the 1500 acres that make up the Mt. Kessler Greenways. Three property owners on Mt. Kessler have already put over 200 adjacent acres in conservation/agricultural easements and the City of Fayetteville has 200 acres for a regional park and a corridor on the ridgeline for a trail.

The University of Arkansas is investigating the purchase of property to relocate its outdoor recreation intramural facilities. One of the properties under consideration includes 180 acres that were part of the failed South Pass development. This parcel is adjacent to the proposed Fayetteville regional park. The balance of the property (460 acres), contains woods, bluffs and trails that we hope can be preserved for future generations.

Chambers Bank owns both of the properties due to foreclosure and would probably provide a good deal, if the University would agree to purchase the combined 640 acres. This could help the University meet the urgent needs created by its recent and planned growth. About 30 acres along Cato Springs would be a superb location for student housing. Using the balance of the land to add hiking, biking, running and nature study to its outdoor recreation program is a low cost way to promote student and staff health improvements.

Please send a personal letter, email or call asking Chancellor Gearhart\* to support locating the intramural facility on the Mt. Kessler property and urging the University to obtain the entire parcel. It is important that he know that the advocates for the UA Mt. Kessler property purchase are Fayetteville residents, as well as UA faculty, students, alumni and other University supporters. The decision on the location of the intramural facility will be made soon. Acting **NOW** is essential.

## CYBERBULLYING: Awareness and Tools for Prevention By Rita Officer and Joyce Hale

Cyberbullying is a worry for young families and educators. Wherever young people have access to computers, whether in homes, schools, cafes, libraries, or other public places, adult oversight is important. This means that even on occasions when children are using grandparents or family friends' computers, there should be an understanding about safety and social good manners.

An audience of 45-65 people attended the Cyberbullying panel discussion at Holt Middle School on October 16. As it had been arranged for Fayetteville School faculty to receive continuing education credit, the majority of the attendees were teachers and social workers. Judging by the large crowd and the time audience members lingered after the program, the evening was deemed a rousing success! Rita Officer served as moderator for the event, which was co-sponsored by the League and Mental Health America.

The panelists (listed following) possessed a wide range of expertise and offered practical knowledge to the audience. Panelists: Dr. Erica Baughfman of Ozark Guidance, Detective David Williams of Fayetteville Police Department, Kelly Zega/Cox Communications Director of Public Affairs, Mike Mason/Holt Middle School Principal and Student Representative - Grayce Randolph/Fayetteville High School Violence Intervention Prevention (FHS VIP) Club President.

In describing her personal experience as a witness of cyberbullying and the price she paid for standing up to the bullying, Grayce exemplified the theme of the evening which was: everyone who is a witness of bullying must call it for the abuse that it is and take steps to stop it. Young people are quite unlikely to tell parents that they are being bullied and all panelists emphasized that adults must take responsibility to protect their children.

Panelist Kelly Zega suggested that a contract between parent and child be created to begin a conversation and establish the ground rules for Internet use. The presentations were emotionally powerful and audience members responded with rapt attention. The panelists agreed to stay and answer individual questions and audience members took advantage of the opportunity. Reporters from local TV news stations conducted individual interviews with some panelists. Tables full of reference materials from a variety of sources such as Cox Communications, Center for Missing and Exploited Children. Ozark Guidance, etc. . . , were quickly depleted.

#### **TAKE CHARGE! FAMILY CONTRACT**

This family contract establishes media use ground rules for our home. Clearly defining these limits helps (name of child/children) and our entire family make smart TV, Internet and Phone choices.

#### SMART CHOICES FOR YOUR COX DIGITAL HOME

#### TV

- I will watch only TV programs and movies that my parents feel are appropriate for me even when I'm not at home or my parents are not around.
- I will respect and comply with the parental control settings in my home at all times.
- I will watch no more than (insert number) hours of non-educational television each day and only after completing my homework.

#### Internet

- I will use only chat rooms and Web sites approved by my parents.
- I will never give out any of my personal information online or use a screen name that tells people I'm a child.
- I will never meet an online "friend" face-to-face.
- I will never respond to offensive or dangerous e-mails, chat, or other communications. If I receive any upsetting or scary messages, I will tell my parents immediately.

#### **Phone**

- I will never talk to strangers on the phone or in person. If I don't recognize the caller, I won't tell them any personal information or reveal if I'm home alone.
- If a phone call upsets or scares me, I will give the phone to my parents or hang up immediately and tell my parents what happened.
- I will not call any 900 or 976 phone numbers without the permission of my parents.

## **Family Contract Usage Tips**

- 1. Customize the highlighted sections (or any portions) of this document. Keep your wording as precise as possible to prevent any misunderstandings.
- 2. Specify rewards and consequences. For example, your child would lose TV watching privileges for a designated amount of time for breaking the rules. Likewise, you could create a reward system with items such as extra allowance for compliance.
- 3. Start by asking your child to establish the rules, consequences and rewards to encourage a sense of ownership. They are more likely to respect the limits if they helped create them.
- 4. Don't hesitate to enforce the family contract. Evaluate your child's behavior regularly and talk about their TV, Internet and phone usage.
