HOSTING THE UKRAINIANS

The League of Women Voters of Washington County received a grant from the LWVUS through the Open World Hosting Program to bring four Ukrainians, a facilitator and translator to Fayetteville in October, 2006. Our guests were young professionals eager to study accountable governance and citizen participation in local government.

Several of our League members met the Ukrainians in Little Rock on October 14th, where we toured the city, visited Central High School and the Clinton Museum. Once in Fayetteville, the group settled into their home-stay quarters and began a busy seven day schedule. Activities included meeting Fayetteville city officials and state elected representatives, attending Drug Court, talking with election officials, and sitting in on a city council meeting. A day was spent on the University of Arkansas campus, where the Ukrainians met with political science faculty and presented a program on their county to the Law School faculty. A tour of the Jones Center and Shop, the hub of family gatherings and services in Northwest Arkansas, and a tour of Tyson's Headquarters filled another day. The final work day gave our Ukrainian friends the chance to meet with local groups in their specific areas of interest and to explore the role of the media in accountable governance. Saturday was "All American Day," and included barbeque and a Razorback football game.

The best way to summarize this visit, which involved many in our League and community, is to share a few quotations from our guests.

"It's the culture. What we lack is the trust and faith you have in your political and legal systems. We have the mechanisms, but not the culture."

"You Americans work hard to make a living, then, when you retire, instead of relaxing, you work hard as volunteers to better your community. This is not the case in our country, and it is something we need to encourage."

"To have groups in the community meet together to discuss how to make the community better is awesome. At home, it is every man for "himself."

From this all-male delegation needing souvenirs to take home to wives and children: "I've never shopped so much in my life. I'll need to get into therapy for this addiction when I get home!"

That a cultural exchange occurred between our League and the Ukrainian visitors was evident at the farewell dinner. Our host's 10 year old granddaughter greeted the Ukrainians at the front door. She was in eastern European dress and held out a tray of bread and salt, the traditional Ukrainian welcome. No matter how modest the home, bread and salt are always available to guests. These men were moved - and speechless.

League of Women Voters of Arkansas 25th Annual Council (Reprint)

On a very rainy and windy day a lively group of *League members tackled water issues* in the Cox Building at Little Rock. Marion Orton provided an update on the Leagues water study. This led to a thoughtful presentation by Washington County League member Joyce Hale on watersheds and impervious cover. The following actions are needed to address the serious issues at risk: 1. Document water sources and create baseline descriptions of quality for public database; 2. Educate contractors; 3. Improve oversight; 4. Create incentives for exemplary construction performance; 5. Impose severe penalties to bad actors; 6. Develop watershed protection organizations.

A panel of three experts David Carruth, President, Ark. Wildlife Federation; Tony Stevenson, Natural Resource Conservation Service; and Joe Krystofik, US Fish and Wildlife Service, Ark. Delta Sub-office provided expertise and opinions from different points of view. League members entered into the discussion with gusto, opinions and insightful questions. The discussion was stimulating and educational.

Clinton School of Public Service Student Malcolm Glover shared his history with the League in Florida on voter service issues and then gave a wonderful presentation on the Clinton School of Public Service, its purpose and his engagement in the program. Mr. Glover traveled to Darfur, Sudan for his summer internship and will complete the masters program this year.

Julie Thompson, Director of Communications with the Arkansas Department of Education provided an update on K-12 education in Arkansas, including recent reforms, financial issues, facilities, curriculum and meeting the goals of No Child Left Behind through a new model which tracks individual student progress.

During the *Council Business Meeting*, the LWVAR voted to recommend the Member-At-Large Unit of Benton County to League status which is processing for LWVUS recognition this month. In addition, an annual budget was adopted for the coming year. Program recommendations included sharing a DVD of the Council's water study presentations and encouraging local leagues to continue to inform themselves on important water issues in their areas and in the state. There is a desire to visit the Grand Prairie Project with Tony Stevenson in this League year. Medicaid in Arkansas was chosen as the area of study for 2006-2007.

Mark your calendars for Convention 2007 to be held in Jonesboro along with the LWVAR Hall of Fame Tribute April 28 – 29, 2007.

At last week's January Board meeting, the LWVUS board voted unanimously to adopt the following 2007 Advocacy priorities: Campaign Finance Reform, Civil Liberties, DC Voting Rights, Election Administration, Ethics and Lobbying Reform, Global Climate Change, and Healthcare Reform. In addition, the Board reaffirmed the League's commitment to maximizing voter education and participation in the months leading up to the 2007 and 2008 election seasons. The Year in Review:

In February the League heard from Speaker Jack Robinson, Superintendent of the Shirley School District regarding the bond issue for building a new high school and replacing the sewer system. The bond issue passed.

Under the guidance of India Olean Brown, an extensive Water Study was completed and findings submitted to Marion Orton. In conjunction with our water study League Members have been invited by the Save Greers Ferry Lake Committee to attend a meeting with State Legislators.

India Olean Brown reported on the new voting machines now being used in Van Buren and Cleburne counties. Ester Bass, Clerk of County was Speaker at the April meeting and explained changes in Van Buren County Voting Procedures. Some members attended a pre-trial use of the new voting machines.

An election for new Board Members was held and the new Co-Presidents are Janet Swanson and Dorothy Lishock; Secretary/Treasurer is Nancy Johnson.

After a two month recess in June and July the League reconvened in August with a "Welcome Back" Tea.

The issues to be considered for the remainder of 2006/2007 are: Elections and reaching out to local voters; The Arkansas School System; and Drilling for gas in Arkansas.

In November, Jon Rainbolt, Special Education Supervisor for the Arch Ford Education Service Co-operative, spoke regarding education issues in Arkansas. This project, under the guidance of Shirley Patterson, will be completed in February, 2007.

Smart Growth in Northwest Arkansas

*Growth is inevitable and desirable, but destruction of community character is not.
The question is not whether your part of the world is going to change.
The question is how.*

The 2000 U.S. Census found that Northwest Arkansas was the sixth fastest growing Metropolitan Statistical Area in the nation. The rapid growth in this area has created economic and cultural opportunities while also causing anxiety about change and problems associated with growth. The critical issues that face communities during periods of rapid growth and exploring ways to address these issues were the focus of the Washington County League's programs for the 2006-2007 year.

A series of five programs began in November, which featured Fayetteville's Natural Heritage Association, a non-profit organization that recently completed a study mapping our watershed's most threatened environmental resources. The program shared the results of the study and engaged the audience in a brainstorming session on how to protect these resources through public policy and organized private efforts. December's program highlighted a partnership between the University of Arkansas's Community Design Center and Habitat for Humanity that will result in a neighborhood of affordable homes be Arkansas's first "green" neighborhood. The designers created an eco-friendly neighborhood by utilizing creative methods for stormwater management and maximizing the energy efficiency of the 17 homes. The project demonstrated the possibility of building neighborhoods that are more environmentally friendly, higher density and offer greater opportunities for community interaction than conventional subdivisions. January's program featured a dialogue between representatives from the Beaver Water District and the audience about the threats of rapid growth to our water supply and policy initiatives that would offer additional protections.

February's program will examine the issues associated with the greater diversity of cultures within a rapidly growing community, and April's program will focus on the issue of sustainability, particularly as it relates to global warming. League members will discuss the policies presented in this year's program at their March meeting and determine whether they should become part of the 2007-2008 Program for Action.

OUR WATER STUDY CONTINUES

How can the people of Arkansas protect the quality and quantity of our water? The Arkansas League has a position on this question. However, new water projects and problems are continuing to occur. Perhaps we need to be more specific in our stand. This past year the various Leagues have looked at problems in their own areas. Does our position cover or give enough guidance to you?

Your assignment #I

- What additions or deletions should be made to our water position?
- Should we add a section on each of the large water users agriculture, industry, wildlife protection, recreation, drinking?
- Should we emphasize methods of conservation and long range sustainability?
- Should special emphasis be on fast growing areas where land and water are being stressed by chemical runoff, change of drainage terrain and heavy construction around drinking water lakes and sources.
- Should we have funding priorities, political criteria, global trade values?

Your assignment #II

Look at the Grand Prairie Irrigation Project DVD. It was filmed at our Council meeting in April 2006. (A local TV channel showed it several times in Fayetteville) David Carruth, President, Arkansas Wildlife Federation; Tony Stevenson, Natural Resource Conservation Service; and Joe Krystotik, U. S. Fish and Wildlife Service, were our speakers. They talked and showed power point as they competed with a pounding rain on the metal roof overhead.

- How does the plan promote conservation and irrigation efficiency?
- In general what is its water agreement plan?
- What is its impact on wet lands?
- What affects unknown outcomes? --global warming, different crops, economy, etc.
- How is the project being funded?

What is the future of the Corps of Engineers, global trading, sustainability as they pertain to this project? Please report to me your opinions, your ideas, whether done as a committee or the whole league. Most important we hope this additional thinking about one of Arkansas's most urgent problems will give us all a better understanding of actions going on in the state and how we can speak up to protect our state's water.
